CODE OF ETHICAL CONDUCT FOR VOTING MEMEBERSHIP:

1. I will provide my cats with clean living conditions, adequate diet, adequate space, proper health care, adequate attention, and in all ways treat them humanely at all times according to generally accepted Cattery guidelines.
2. I will never place a cat or kitten with a buyer if I suspect that these conditions will not be met.
3. I will never give or sell kittens to pet shops or distributors for same.
4. I will always give my clients an honest appraisal of any cat or kitten, including its quality, potential as a show cat or breeder, and eligibility for registration. I will make every effort to see that my buyers get what they pay for.
5. I will always provide my buyers with a written contract (agreement) specifying the conditions of all sales, stud service, boarding, and all other transactions.
6. I will always provide a written pedigree and registration application(s) in a timely manner to all buyers.
7. I will always make every effort to assure that the cat/kitten purchased from me is delivered in a healthy condition, free of infectious disease(s) and parasites.
8. I will always act in the best interests of the LaPerm breed and in a way that will reflect favorably on my fellow LaPerm breeders. If any disagreements or misunderstandings regarding my conduct should arise; I will make every effort to see that they are resolved to the satisfaction of all parties. If I cannot resolve such complaints myself, I will submit them to the LaPerm Fanciers' International Ethics Committee for arbitration.
9. I also agree that I will periodically provide written reports of shows attended and litters produced along with names of sire and dam and all kittens. I will also provide any information as to birth defects including that of stillborn kittens or those lost at later times and the causes of such losses.
10. As a voting member of LFI, I agree to register and show cats in order to help promote the breed and understand that I may lose my voting privileges if I don't adhere to this requirement.

BY SIGNING BELOW, I CERTIFY THAT I HAVE A REGISTERED CATTERY NAME, THAT I HAVE EITHER REGISTERED AT LEAST ONE LITTER OF KITTENS WITHIN THE PAST 2 YEARS WITH RECONZIED CAT BREED ASSOCIATION, OR I HAVE SHOWN AT LEAST ONE LaPERM IN AN APPROVED CAT SHOW, OR AM A BREED COUNCIL MEMBER OF A RECOGNIZED CAT BREED REGISTRY. I WILL DOCUMENT THESE ACTIVITIES IF REQUESTED. I ALSO AGREE TO FOLLOW THE LaPERM FANCIERS' INTERNATIONAL GUIDELINES ABOVE.

CODE OF ETHICAL CONDUCT FOR ASSOCIATE MEMEBERSHIP:

1. I will strive to be supportive of the LaPerm breed in all activities.
2. I will provide my cats with clean living conditions, adequate diet, adequate space, proper health care, adequate attention, and in all ways treat them humanely at all times.
3. I will never allow my cats to roam freely outside unsupervised.
4. I will always act in the best interests of the LaPerm breed and in a way that will reflect favorably on my fellow LaPerm breeders and owners, and promote the breed within recognized Cat Registries I may be a member of. If any disagreements or misunderstandings regarding my conduct should arise; I will make every effort to see that they are resolved to the satisfaction of all parties. If I cannot resolve such complaints myself, I will submit them to the LaPerm Fanciers' International Ethics Committee for arbitration.
5. I also agree that I will provide periodic written reports of shows attended. I will also provide any information as to health issues that might arise and the causes of such losses.
6. As a member of LFI, I agree to register and show cats in order to help promote the breed and understand that I may lose my membership if I don't adhere to this requirement.
